US41 Corridor Study Public Meeting

The first public meeting was held October 3rd and there was standing room only for the presentation and input. A survey was also presented and everyone was asked to choose their preferences from a list of choices.

There is a second meeting on November 7, 2017 from 6:00pm - 8:00pm at the Eagle Lakes Community Park, 11565 Tamiami Trail East.

The purpose of this Study is to determine the public's preferences for future development types and uses so that those types of development and uses can be facilitated and incentivized through Comprehensive Plan policies and Land Development Code. We urge everyone to attend.

Cirrus Pointe in the Bayshore Triangle on Thomasson submitted changes to the PUD to build low income housing. With all the work Bayshore Community Redevelopment is and has been doing to improve the area and the number of affordable homes still in existence there, the change was denied by the County Planning Commission.

The food truck plans on Bayshore across from the Three60 Market & Restaurant are still in the permitting stage.

The beer garden planned for Bayshore is unfortunately in a lawsuit with a business owner to block them from coming to the area.

The Whitaker Road Habitat for Humanity PUD application changes have been extended for 6 months.

California Closets will be coming to the Stock Plaza on Collier Boulevard.

Aspen Dental is building on an outparcel in the Steinmart plaza at the corner of US41 and SR951.

Shadowcreek on Rattlesnake in front of Hibiscus has decided to not build the condo community they had planned there.

The Davis/US41 project in the Bayshore Triangle is asking for changes to their PUD to build just a hotel and eliminate the residences and commercial spaces.

Hurricane Irma Debris Removal

The estimated four to five million cubic yards of debris caused by Hurricane Irma are being collected by Collier County's emergency debris removal contactor AshBritt, Inc. Storm debris includes trees, branches, shrubs and other vegetation that was downed during the storm. It also includes downed fencing, flooring, furniture, wallboard and other debris that must be removed from homes due to structural damage or flooding.

Hurricane Irma impacted a broader area of the county than previous storms. The storm also impacted counties throughout the state - circumstances that make post-storm debris removal challenging.

"We understand people are frustrated and want the debris to go away quickly," said Collier County Public Utilities Deputy Department Head Dan Rodriguez. "The volume of debris caused by Hurricane Irma throughout the county and the state presents unique challenges. We are working closely with our contractors to provide additional resources as they become available."

Among the challenges -

- Contractor shortages: Debris-removal is a specialized service and many of the debris-removal contractors have resources allocated to cleaning up in Texas after Hurricane Harvey made

landfall August 26. Hurricane Irma impacted nearly all 67 counties in Florida, causing additional resource allocation issues. Our belief is that as other counties that experienced less impact are cleared of debris, more debris

removal assets will be available to Collier County.

- Low wires: Contractors are still experiencing delays getting into some areas due to low hanging wires.

As of close of business yesterday, Tuesday, Oct. 10, 2017 a total of 399,714 cubic yards of debris had been collected. While debris collection began in the hardest hit areas including: Chokoloskee, Everglades City, Copeland, Goodland and Immokalee, AshBritt currently has 108 debris units collecting debris throughout the county.

Storm-related yard waste should be separated from construc-

tion/demolition debris, including furniture and appliances. Do not put yard waste in plastic bags. The yard waste is being ground into mulch and plastic cannot be in the mulch. When placing yard waste curbside, avoid blocking the road, driveways, sidewalks (especially near schools), mailboxes, water meters, backflow prevention devices, fire hydrants and utility poles. The debris will be collected using claw trucks that require room to maneuver. Placing debris pile to close to other objects could result in property damage. Do not block storm drains or swales with debris.

Collier County's solid waste haulers, Waste Management Inc., of Florida, and Waste Connections have resumed regular curbside collection of trash, recycling, and conforming yard waste. Residents can help speed the cleanup by placing compliantly prepared yard waste out for weekly collection. This includes yard waste that is in paper bags, personal containers, or bundled and tied. Each bag, bundle or container needs to weigh less than 50 pounds. Bundles need to be less than four feet in length with no branches more than four inches in diameter.

Help For Homeowners With Hurricane Damage

On Tuesday, October 10, 2017, the Board of County Commissioners approved the use of State Housing Initiatives Partnership (SHIP) funds to provide Hurricane Irma disaster relief to qualifying Collier County citizens.

A limited pool of SHIP funds is being made available at varying income levels to assist homeowners with damages resulting from Hurricane Irma. All households will need to income qualify. There are three programs available: disaster mitigation, owner occupied rehabilitation and demolition and replacement of site built mobile/manufactured housing.

Those that income qualify may be reimbursed for expenses for repairs that have already been paid and/or for planned repairs. Qualified home owners may utilize these funds for insurance deductible reimbursement.

Applications are taken daily at Community and Human Services, 3339 Tamiami Trail East, Room 211, Naples, Florida 34112.

Debris Removal Criteria:

Debris in the County right-of-way's.
Horticulture debris must be **separated** from construction debris and bulky items.
Horticulture waste must be in piles and not in containers or plastic bags.
OR it will not be picked up.
